Wrestling Ticket Plan

Provisions for participating schools: A ticket order form will be mailed to all schools that entered Wrestling in 2009-10.

Any member school that has entered the Wrestling State Series will have the opportunity to purchase advanced reserved tickets (Sections A and B). Each school shall be guaranteed fifteen (15) reserved tickets. Schools wishing to purchase additional advanced tickets may do so with the understanding that only fifteen (15) shall be guaranteed to be reserved seats. More than fifteen (15) might be General Admission C Section if all seats run out. However, once all the member school guarantees have been filled, any remaining reserved tickets will be sold to those schools requesting additional reserved seats on a first come first served basis. The ticket order cards must be postmarked by December 7, 2009. Ticket orders for schools will be filled beginning December 14, 2009 for all schools that had the ticket order card postmarked by December 7, 2009.

Provisions for general public:

General Public orders will be filled beginning December 21, 2009. General Public may download an order form from the IHSA web site and mail their ticket requests to the University of Illinois. General public tickets will be filled on "first come first serve" basis with best available reserved seats.

Note: Member schools may order \$40, or \$32 season tickets and may order more than the guaranteed fifteen (15) season tickets. After the December 7, 2009 deadline, and after the guarantees have been met, additional requests will be filled on a "first come, first serve" basis. General Public will be filled starting December 21, 2009 on "first come, first serve" basis, best available seats. If tickets are not available at the price for which you submitted payment, you will be sent the next lesser-priced tickets and the overpayment will be refunded to the person on the ticket order.

Tickets may be paid for by school check, personal check or credit card. All tickets and applicable refunds will be mailed to the name and address that appears on the order card. If a credit card (Discover, MasterCard or Visa), is used, the expiration date must be 2009 or later. **Checks are to be made payable to the University of Illinois.**

Walk up and over the phone sales will not begin until January 11, 2010. Inquiries regarding orders should be directed to the ticket office at 1800 S. First Street; Champaign, IL. 61820 or call (217) 333-5000.

December 21, 2009	Process orders for general public (first come first serve)
January 11, 2010	Open sales to walk up and phone orders

Note: Individual session tickets will only be available for purchase at the door the day of the tournament.
