ITEMS OF GENERAL DISCUSSION:

- 1. The committee discussed the high risk ranking for boys and girls lacrosse as determined by the Illinois Department of Public Health (IDPH). The committee questioned whether girls lacrosse should and could be made to be a medium risk sport.
- 2. The committee heard an update on the IHSA lacrosse season for 2020, which will be played in the summer season from April 19 to June 26.
- 3. The committee discussed what a postseason format might look like within IDPH Regions.
- 4. The committee discussed the contact day limitations for lacrosse that can currently be conducted until October 31.
- 5. The committee heard a report on officials licensing for the 2021 season. The IHSA will leave 2021 licensing open until the season begins. Licensing for the 2021-22 school year will open on July 1.
- 6. The committee discussed the creation and review of a Return To Activities document prior to the 2021 season.
- 7. The committee discussed the independent team rule and participation as it relates to this summer's season.

- 8. The committee discussed the pros and cons of allowing participation on high school and clubs team simultaneously.
- 9. The committee discussed meeting again virtually in January to determine the outlook and next steps for the 2021 season.
- 10. The committee discussed scheduling timelines for 2021, as well as the role conferences will play.
- 11. The committee discussed forming temporary conferences for 2021 with independent teams to help ease scheduling.
