# ADMINISTRATIVE RECOMMENDATIONS

# 1. IHSA Return to Activities 1.0

**Recommendation**: The committee reviewed Return to Activities 1.0. The committee made the following recommendations for the IHSA Board of Directors to review in order to make the Summer (May 3- June 26) more equitable with other IHSA 1.0 seasons.

- Allow softball practices to begin on April 19.
- Contests can begin on May 3.
- Follow IHSA By-law 5.225 and eliminate the restriction for the number of games allowed per week. If 35 games are not allowed come as close to that number as acceptable.
- Allow high school softball players relief to By-law 3.101 on June 4.

**Rationale:** The revisions will assist in keeping softball players in Illinois committed to the high school game and create a more equitable summer timeline in comparison with the other IHSA seasons.

#### **ITEMS OF GENERAL DISCUSSION:**

- 1. The committee heard a report from IESA softball administrator Nicole Schaefbauer. IESA Softball will be conducting regionals only at the higher seeded team due to the Covid-19 pandemic.
- 2. Tracie Henry reported that the 2020 softball season was truncated due to the Covid-19 pandemic.
- 3. The committee reviewed the minutes of the 2019 IHSA Softball Advisory Committee meeting.
- 4. The committee discussed the NFHS would not be printing new rules books for the 2021 Softball season due to the Covid-19 pandemic. Officials and coaches are instructed to keep their 2020 rules books.

- 5. The committee expressed their hope to have a full IHSA Softball State Series in 2021.
- 6. Tracie Henry communicated the IHSA Board of Directors action to approve a recommendation for the IHSA Girls Softball State Finals to move to the Louisville Complex in Peoria beginning in 2021. The contract encompasses five seasons from 2021-2025.
- 7. The committee recognized J.D. Koziarski, Kevin Hayhurst and Travis Pate for their service to the IHSA Softball Advisory Committee after the final meeting of their terms.
