Minutes of the 2020-21 IHSA Music Advisory Committee April 28, 2021

Ben Stewart, Music Wire, and Darcy Nendza, Executive Director, ILMEA, were also in attendance. Vocal Director Richard Nunley from Chicago Kenwood High School was unable to attend. Susie Knoblauch, IHSA Assistant Executive Director, conducted the meeting.

TERMS AND CONDITIONS RECOMMENDATIONS

MUSIC SOLO & ENSEMBLE CONTEST

Item 1. Music Solo/Ensemble Terms and Conditions

Recommendation: Change **VIII.B.I.** Subsection **408** to "Other Strings"

Rationale: This change would allow for multicultural stringed instrument musicians to have representation in the contest. It would include non-standard American instruments such as the Ukulele, Banjo, Fiddle, pedal steel guitar and world strings such as the Zither, Sitar, Hammered Dulcimer, Mandolin, and others. As long as written music is present, the instrument could be performed.

Item 2. Music Solo/Ensemble Terms and Conditions

Recommendation: Adjust "Orchestra" category to reflect the broader term "<u>Strings</u>" throughout the document. Most notably **Article X.C.4**, and on the winning groups plaques.

Rationale: This change would reflect all instruments in the Strings Category of approved Solo Events and not just the orchestral strings.

Item 3. Music Solo/Ensemble Terms and Conditions

Recommendation: Delete required Scales and Tonal Skills Section

Appendix A, REQUIRED INSTRUMENTAL SCALES

Rationale: In reviewing scales, the committee discussed a recommendation from 2019-20 that addressed the elimination of scales at contest. After discussing, the committee approved removing these elements of the Solo & Ensemble Music Contest. By taking this requirement out of the music contest, more students will be encouraged to participate.

Item 4. Solo & Ensemble Contest Terms and Conditions

Recommendation: VIII. A. 2. SWEEPSTAKES MAXIMUMS

The following maximums apply when counting for Sweepstakes points

Solos:

Vocal Solos 20 35 String Solos 20

Wind and/or Perc. Solos 35

Ensembles:

Vocal Ensembles 20 22 Brass Ensembles 9 Percussion Ensembles 4 String Ensembles 9 Woodwind Ensembles 9 Piano Duets 4

Choirs:

Flute Choir 1
Clarinet Choir 1
Woodwind Choir 1
Brass Choir 1
Percussion Choir 1
Bell Choir 1
String Choir 1
Vocal Choir 3

Rationale: This change would balance the vocal and instrumental events. The parity of sweepstakes points between band and choir would equalize the number of sweepstakes points possible. Currently, the sweepstake maximums are skewed towards band and a school with a

strong band program could win the overall sweepstake with very little help from vocal programs. In summary:

Vocal Totals = 35 vocal solos + 22 vocal ensembles + 6 vocal choirs = 63

Instrumental Totals = 35 wind/percussion solos + 9 brass ensembles + 4 percussion ensembles + 9 woodwind ensembles + 6 instrumental choirs =**63**

String Totals = 20 string solos + 9 string ensembles + 4 piano duets + 1 string choir = 34

Data from 2020 Music Solo & Ensemble Contest that guided the adjustment to the proposal:

Wind/Percussion Ensembles - 1,683

22 per school count, 51% of ensembles, 40% of ensemble max

Vocal Ensembles - 1,315

20 per school count, 40% of ensembles, 36% of ensemble max

String Ensembles - 330

13 per school count, 10% of ensembles, 24% of ensemble max

Wind/Percussion Solos - 3,236

35 per school count, 45% of solos, 47% of solo max

Vocal Solos - 3,003

20 per school count, 42% of solos, 27% of solo max

String Solos - 966

20 per school count, 13% of solos, 27% of solo max

Wind/Percussion Choirs - 189

6 per school count, 49% of choirs, 60% of choir max

Vocal Choir - 150

3 per school count, 46% of choirs, 30% of choir max

String Choir - 16

1 per school counts, 5% of choirs, 10% of choir max

Item 5. Organizational Contest Terms and Conditions

Recommendation: II. DATE AND SITES - Organizational Contest Date for 2022 & 2025.

A. Date: The contest will be held on April 15-16, <u>8-9</u>, 2022 ... April 18-19, <u>11-12</u>, 2025. Host sites may adjust contest dates due to spring break conflicts.

Rationale: This adjustment addresses conflicts in contest dates.

- Reviewed this year's virtual contests and surveyed the use of continuing with some virtual contest options in the future.
- The Association concluded Virtual Music Solo & Ensemble and Organizational Contests recently. The IHSA thanked all of the schools that served as virtual hosts. Over 1,000 music ensembles and 4,000 music solos were performed for adjudication during this year's virtual music S/E Contest and over 170 large groups performed for the Organizational Contest.
- 2021 Contest Results were reviewed. Congratulations to the following schools who placed first in their respective divisions: Broadlands (Heritage), Stockton, Taylor Ridge (Rockridge), Chicago (High School for the Arts), and Dunlap High School.
- Discussed that etudes as solos can be used at the director's discretion
- Reviewed accompanist issues and the expansion of allowable media accompaniment for S/E
- Examined an editorial revision needed to address conflicting information on how to number measures
- Explored the appropriateness of material style and determined that will be at the discretion of the director
- Analyzed ways to increase the educational value of contests and explored implementing clinicians
- Explained that CPDU credit for meetings are available
- Reviewed updates from NFHS Music, NFHS Return to Music Guidance & Resources, NFHS Copyright Resources, Aerosol Spray Study, COVID-19 Relief Funding for Music Education, Safer Schools and Campuses – Best Practices for In Person Music and the Arts ARE Education National Campaign
