TERMS & CONDITIONS RECOMMENDATIONS

1. Item: VIII. Tournament Rules G. Players in Team Uniform

Recommendation: G. Players in Team Uniform: In each of the tournaments, no school shall have in uniform more than $\frac{30}{35}$ participants. No more than a total of $\frac{35}{40}$ persons from a school may be on the team bench.

Rationale: Starting the 5th year of the state finals, programs are increasing in size. This rule change allows both boys and girls to increase rosters to 35 players dressed and 40 persons total on the bench. This modest increase in participants/bench can be accommodated with the outdoor sideline space. No additional awards will be needed. The medallion number is capped, and additional awards can be purchased at the school's expense.
