## **Items of Discussion**

- 1. The committee heard a presentation from IHSA Director of Information Technology Matt Jensen on the IHSA's forthcoming online transfer management system that will be used to manage transfer eligibility rulings.
- 2. The committee reviewed the by-laws that were passed via an all-school IHSA membership vote during the IHSA's 2023 legislative process.
- 3. The committee reviewed classification policies, multiplier policies, and success formula policy data from other state high school associations.
- 4. The committee reviewed a classification proposal that may be considered by the IHSA Board for the 2025-26 school year.
- 5. The committee discussed the IHSA multiplier waiver process.
- 6. The committee discussed the stigma surrounding social media postings for eighth grade "signing days" as well as by high school students when transferring schools and if solutions exist for curtailing these types of posts.
- 7. The committee reviewed data and discussed policies used by other state high school associations regarding free/reduced lunch percentages and student mobility.
- 8. The committee discussed the IHSA Girls Flag Football State Series, which will debut in the Fall of 2024.
- 9. The committee discussed the forthcoming IHSA Football Playoff ad hoc committee.
- 10. The committee discussed NIL at the high school level.

11. The committee reviewed a letter from the administration at Neoga High School regarding IHSA by-
laws for students paying tuition at a public school. The committee supported Neoga's position and
encouraged the school to submit a by-law proposal during the 2024 legislative session.
