Security Policies

In response to the need for heightened security procedures, Grossinger Motors Arena has implemented the following policies to ensure a safe, enjoyable event experience for all guests. The Grossinger Motors Arena prohibits certain items into the facility including weapons, pocket knives and other hazardous or potentially dangerous items. Be prepared for inspection as you enter the facility. **This inspection will include the use of metal detectors.**

Bags no larger than 13” x 13” x 13” will be permitted inside the Grossinger Motors Arena. Guests who have bags larger than this size will be asked to return them to their vehicles or discard them. **All other bags, purses or personal items of any size will be subject to search.** In the event that prohibited items are revealed during a search, the guest will be permitted to return to their vehicle or the item will be confiscated prior to entrance. An exception will be made for medically necessary items after proper inspection. The Grossinger Motors Arena is unable to store over-sized or prohibited items.

Q. What items do I need to remove from my pockets or clothing before walking through the metal detectors?

A. Guests will be asked to remove all items including keys, phones, mobile devices, wallets/money clips, etc.

Q. Do I have to remove my shoes and other metal including belts, jewelry, hair clips, etc...?

A. Unlike at an airport, guests will NOT be asked to remove shoes, belts, small jewelry, hair clips or small amounts of loose change during the initial screening.

Q. What happens if an alarm sounds?

A. If an alarm is triggered, a secondary search will be conducted by a certified security staff member.

For some events, hand-held security wandling will also be used on all patrons entering the facility. Guests will be required to remove hats and empty pockets of all items to be hand wanded. Some additional screening may be required.

The Grossinger Motors Arena has a no outside food or beverage policy.

Outside vendor items cannot be brought into the arena for distribution.

Accessible Parking/Drop Off

Accessible drop off and parking is available at the Grossinger Motors Arena. There is a parking deck located on the south side of the building that has a limited number of accessible spots available. In addition, there are accessible spots in surrounding parking lots. Drop Off is located at the VIP entrance on Roosevelt Ave.

While we will do everything in our power to be as quick and efficient as possible, we encourage guests to please arrive, in advance of the scheduled start time, in order to allow ample time to enter the facility safely.
