## Monitoring Coaches Compliance (located in the IHSA Schools Center)

- 1. go to www.ihsa.org and select Schools Center login in the upper right hand corner of the page.
- 2. enter your login and password
- 3. select 'Staff Responsibilities'
- 4. select 'Staff Compliance' (this will be found in the light yellow field near the top of the page)

5. a list of all the coaches your school has entered into the IHSA Database will appear; those that are not in compliance will appear at the top of the list and a display of "not in compliance" will appear in the 'Status' column next to the person's name; if the coach has not completed either the required concussion education program or the PES program, the fields for that coach will be blank
