From the Executive Director

Policy 17 Overview

<u>Classification Cycle</u>: Classifications will be made annually rather than every two years using the most recent September 30th enrollment data.

<u>Classification Cutoffs</u>: Cutoffs between classes will be fixed rather than percentage based. See the policy language for cutoffs in each multi-class sport/activity.

<u>1.65 Multiplier</u>: The actual enrollments of all non-boundaried schools will be multiplied by 1.65 for classification purposes. **Please note that the multiplier does not bump all non-boundaried schools up to a higher class.**

<u>Multiplier Waiver</u>: Automatic waivers are no longer given to sport and activity programs of non-boundaried schools. Schools seeking a waiver from the multiplier for a sport or activity must apply through the online Schools Center. This must be done annually.

Applications will be reviewed by IHSA staff, and recommendations for approval or denial of a waiver will be given to the IHSA Board of Directors. The IHSA Board of Directors has final authority over application decisions.

<u>Success</u> Adjustments: Non-boundaried school programs will be subject to a success adjustment should a program win two IHSA state trophies over the last three years rather than the last two years. <u>Cooperative Teams</u>: The multiplied enrollments of non-boundaried schools will be used for classifications of cooperative teams unless a waiver has been approved in that sport or activity for the nonboundaried schools involved.

<u>Multiplier Waiver</u>: Should a team at a nonboundaried school be moved up to a higher class after being multiplied, the school may consider applying for a multiplier waiver. Before applying, schools should determine whether they meet the criteria to apply.

Again, being multiplied does not move all non-boundaried teams to a higher class. If the multiplier does not change a school's classification in a certain sport or activity, there is no need to apply for a waiver.

If there is a change in a team's classification after being multiplied, then the success of that program must be reviewed before applying. Should a team achieve a certain level of success over the last three school terms, the school will not be eligible to apply for a waiver in that sport or activity.

Teams that do not meet the success criteria are eligible to apply for a waiver. Being eligible to apply does not guarantee that a waiver will be granted. Information collected from the application will be reviewed for consideration of a waiver.



IHSAF Scholarships

The IHSA Foundation will be offering \$14,000 in scholarships to class of 2025 seniors. The Foundation supports senior students who are either planning to pursue one or more of the following career paths:

- (1) major in education,
- (2) return to the coaching profession, or
- (3) are a current IHSA licensed official.

Each school can nominate one student for a \$1,000 scholarship. The scholarship does not require a minimum GPA or test score. IHSA School Official representatives will receive an email on March 20 with the submission link to forward to the school's nominee. The deadline for submission is April 11 with the winners being recognized virtually the week of April 28.

A date is defined as a single day on the calendar. A two-day non-conference meet or tournament during the regular season counts as two dates. However, per Illustration 270 in the IHSA Handbook, a two-day conference meet or tournament is considered to be one date.

Spring Sports Safety in Cold Weather

Early spring weather can be unpredictable in Illinois. To prepare for weather changes through games or practices, athletes are encouraged to wear appropriate layers with moisture-wicking or wind protection. Wind and precipitation can increase the chance of cold-weather injury. Coaches should have plans for deteriorating weather conditions such as decreasing time outside, allowing athletes opportunities to rewarm, or rescheduling if conditions worsen past a playable point. Coaches should always consult their own specific policy or athletic trainer for further information regarding practicing in cold temperatures.
