### Wrestling Ticket Plan

**Provisions for participating schools: Order Form** is available on-line in the School Center – click on “Forms and Other Resources”.

Any member school that has entered the Wrestling State Series will have the opportunity to purchase advanced reserved tickets (100 Level). Each school shall be guaranteed fifteen (15) reserved tickets. Schools wishing to purchase additional advanced tickets may do so with the understanding that only fifteen (15) shall be guaranteed to be reserved seats. Orders exceeding fifteen (15) tickets may be seated in general admission (200 Level) if all reserved seating is sold. However, once all the member school guarantees have been filled, any remaining reserved tickets will be sold to those schools requesting additional reserved seats on a first come, first served basis. Schools may download an order form from their School Center and mail their ticket requests to the University of Illinois Ticket Office. The ticket order form must be postmarked by January 6, 2023. Ticket orders for schools will be filled beginning January 10, 2023, for all schools that had the ticket order postmarked by January 6, 2023.

#### **Provisions for general public:**

The general public can order tickets beginning January 17, 2023. Tickets can be purchased online at [www.fightingillini.com](http://www.fightingillini.com), over the phone by calling 1-866-ILLINI-1 or 217-333-3470, in person at the Illinois Ticket Office at 1800 S. First Street, Room 1000, Champaign, IL 61820, or by downloading an order form from the IHSA website and mailing the ticket form to the Illinois Ticket Office. Tickets ordered online or over the phone are subject to ticket fees. Order forms may be mailed in prior to January 17, but will not be processed until this date. General public tickets will be filled on “first come, first serve” basis with the best available reserved seats.

**Note: Member schools may order \$60, or \$50 season tickets and may order more than the guaranteed fifteen (15) season tickets. After the January 6, 2023 deadline, and after the guarantees have been met, additional requests will be filled on a “first come, first served” basis.**

**General public orders will be processed starting January 17, 2023 on a “first come, first served” basis with the best available seats. If tickets are not available at the price for which you submitted payment, your order will be processed at the next available price point and the overpayment will be refunded to the person on the ticket order.**

Tickets may be paid for by school check, personal check or credit card. All tickets and applicable refunds will be mailed to the name and address that appears on the order card. If a credit card (Discover, MasterCard, Visa or American Express), is used, the expiration date must be 2023 or later. **Checks are to be made payable to the University of Illinois – Please be sure to include the shipping and handling fee.**
