# TERMS AND CONDITIONS RECOMMENDATIONS

#### 1. Recommendation: Article VIII-F-1

Add this item as d. and readjust the remaining items for Boys and Girls Tennis: "Coaching may occur for a maximum of 90 seconds prior to the beginning of a tie breaker and when players switch sides during the tie breaker."

**Rationale:** It can be a decisive time in a match and coaches should have the opportunity to coach their players during this key moment.

- 2. Kevin Schrammel presented an overview of the 2013 Girls State Final.
- 3. Susie Knoblauch reviewed the results & discussion items from the state final surveys.
- 4. Discussed use of USTA officials at the state tournaments.
- 5. Discussed the possibility of having sectional complexes.
- 6. Discussed regular scoring vs. no-ad scoring for the girl's state final. This was tabled to allow for more review.

- 7. Discussed changing the start time for the Boys Tournament to 9:00 on Thursday. This was tabled to allow for more discussion.
- 8. Recommended listing the seeding committee online with their e-mails.
- 9. Recommended sending a "probationary" letter to the AD of the coaches who do not submit the complete match schedules for each of their state series players/entries.
- 10. Recommended making the List of Participants available on the first practice date so that the coaches can complete their records throughout the entire season.
- 11. Discussed having stats added for all of the positions during the regular season rather than just 2 singles and 2 doubles so coaches could use the entry form as an electronic scorebook.
- 12. Recommend placing a tutorial in the rules video on how to complete the List of Participants.
- 13. Rob Beck from Streator (Twp.) and Angela Woods from Effingham (H.S.) were recognized for their service as the Division 4 and Division 5 representatives to the IHSA tennis advisory committee.
